II. Meeting Notice and Roll Call

IV. Executive Session - 6:08 p.m. - Governor Livingston High School Conference Room 131

On motion by Ms. Bradford and seconded by Mr. Dillon, and approved by all present, the Board recessed into closed executive session at 6:08 p.m.

WHEREAS, the Berkeley Heights Board of Education seeks to adjourn to Executive Session in full compliance with the Open Public Meetings Act, N.J.S.A. 10:4-6 et seq.; and

WHEREAS, the Open Public Meetings Act provides that a public body may exclude the public from that portion of the meeting at which it discusses matters related to those identified below:

- a. Matters rendered confidential by Federal Law, State Law, or Court Rule

- b. Individual privacy
- c. Collective bargaining agreements
- d. Purchase or lease of real property if public interest could be adversely affected
- e. Investment of public funds if public interest could be adversely affected
- f. Tactics or techniques utilized in protecting public safety and property
- g. Pending or anticipated litigation
- h. Attorney-client privilege
- i. Personnel – employment matters affecting specific prospective or current employees.

BE IT RESOLVED, that the Berkeley Heights Board of Education adjourns to Executive Session to discuss matters related to students, legal, and personnel matters; and

BE IT FURTHER RESOLVED, that the minutes of the discussion of any of these items will be disclosed to the public when matters have been determined and confidentiality is no longer applicable.

V. Return to Public Session

On motion by Ms. Bradford and seconded by Mrs. Joly, and approved by all present, the Board closed the executive session and returned to the public session at 6:51 p.m.

Due to a lack of quorum, the Board was unable to continue the meeting and adjourned the session. The Board apologized to the public, noting that the quorum issue was unforeseen and was not identified until after the meeting had begun.
